Absolutely no dumping of tires, paint, concrete, hazardous-materials, radioactive materials, hazardous chemicals, or asbestos. Customers assume the responsibility of all fines and fees associated with these materials.

Customers assume full responsibility and full liability for any damages to the trailer that may occur during their rental period.

Keep children away from the disposal trailer. Absolutely no playing in, on, or around the disposal trailer.

Customer assumes full responsibility and full liability for any and all injuries that may occur during rental period.

Disposal trailers are to remain in the same spot that the customer requested the trailer to be parked in. If the trailer needs to be relocated to a spot other than what the customer originally requested, a \$100.00 relocation fee will apply.

Customers are only allowed to fill disposal trailers level with top of the trailer. There will be an additional charge of \$100.00 or more for overfilling the trailer.

NOTE: Our delivery trucks and equipment are heavy. RITWAY DUMPSTER SERVICE, INC. assumes no responsibility for any damage to your driveway or property caused by our trucks or equipment during the delivery or retrieval or the rented equipment.

I have read and fully understand that RITWAY DUMPSTER SERVICE, INC is not responsible for any damage to our driveway or property caused by their delivery trucks or equipment in the course of delivery or retrieval of the rented equipment. Nor is RITWAY DUMPSTER SERVICE, INC. responsible for any injuries that may occur during the rental period.
